**A RESOLUTION ESTABLISHING THE  
STANDARD WORK DAY AND REPORTING  
TO THE NY STATE AND LOCAL  
EMPLOYEES' RETIREMENT SYSTEM**

**WHEREAS**, The New York State Retirement System requires that all elected and appointed officials, who are members of the retirement system and are not in a time & attendance system; maintain records of activities for three consecutive months within 150 days of the start of a new term or appointment; and

**BE IT RESOLVED**, that the City of Hudson/Location Code 20020 hereby establishes the following as standard work days for elected and appointed officials and will report the following days worked to the New York State and Local Employees' Retirement System based on the record of activities maintained and submitted by these officials to the clerk of this body:
